4. UNFINISHED BUSINESS:

4.1: Lakeshore Erosion Project Update:

WSP Group provided Council with a draft progress report for the shoreline Erosion Projection. They are still working on the existing storm outfall application review with AB Environment under the Code of Practice.

Questions from Council:

What keeps the sloped rock from rolling into the lake?

Is the riprap big enough?

The dock location for Lot 4 can be placed anywhere in the middle of the lot but not in front of the large pine tree.

The outfall is to be extended through the berm into the lake so the drainage water is not backed up behind the berm.

Council would like an invitation sent to WSP to attend the Pancake Breakfast Aug. 5 to talk with the residents about the proposed project.

4.2: Dry Hydrant Project Update:

WSP did not have an update at this time. Council would like to engage in further discussions with Clearwater County to get their feedback on the preliminary planning.

5. NEW BUSINESS:

5.1: Weed Inspector Appointments:

The Summer Village of Burnstick Lake has requested to use Clearwater County's Weed Inspectors to enforce the Weed Control Act within its boundaries. This

program operates under the delegated authority of the Provincial Weed Control Act and Regulations. Within the Weed Control Act, Part 2 section 7(1) A local authority shall appoint inspectors to enforce and monitor compliance within this Act within the municipality.

21-17-06-24 MOVED BY Councillor Madge to appoint the following Clearwater County
Agricultural Services and Landcare staff – Sarah Titford, Taylor Michalsky, and
Brittany Willsie - as Weed Inspectors under the Alberta Weed Control Act for the
Summer Village of Burnstick Lake for 2017 for field and administrative duties as
directed by Clearwater County's Agricultural Service Board.

5.2: Weed Inspection 2016 Report:

During the week of July 26-30, 2016, Clearwater County completed a weed inspection at the Summer Village. Two noxious weeds were identified – ox eye daisy and tall buttercup. Locations were also identified. Under the Weed Control Act, persons shall control noxious weeds that are on the land the person owns or occupies.

5.3: MSI Capital – Amending Agreement:

The provincial government is committed to providing stable, predictable funding to municipalities. As a result they have extended the MSI Capital program for two years. To extend the program the funding agreement for MSI must be amended. MSI funding allocations will not be made until the agreement is signed and returned.

5.5: Fire Pit Inspections:

As there has been no success in recruiting someone to complete fire pit inspections Council would like a form developed to allow residents to complete their own inspection and return same to keep on record with the Summer Village. The onus is on the residents to ensure that they meet the requirements of the bylaw and will assume full responsibility and liability for their fire pit.
